Govt relaxes local sourcing norm for tech innovators

New Delhi, July 20: The Cabinet on Wednesday approved a three-year exemption from 30% annual local sourcing required for foreign single-brand retail companies with "cuttingedge technology", paving the way for global players like Apple to open their first retail store in India.

Also, the companies like Apple will be given the flexibility to source an average of 30% locally over a fiveyear period once the threeyear exemption from the sourcing rule is over. These changes were announced last month by the department of industrial policy and promotion. Upon completion of the first three

However, by the end of the fifth year, such entities must have sourced an average of 30% locally over that five-year period. This means they may not strictly adhere to the annual 30% sourcing rule in any of those five years. Once the relaxed regime is over, they are mandated to comply with the mandatory 30% sourcing rule every year.
